## 1-YEAR WARRANTY

Manac guarantees to the original purchaser, for a period of one (1) year following the in-service date that the purchased trailer (the "Equipment") will be free from defects in workmanship and materials. Notwithstanding the foregoing, the components, parts and accessories not manufactured by Manac but which are included or added to the Equipment are subject, as the case may be, to their manufacturer's warranties and Manac will provide no additional warranty in their regard. Manac makes no warranty, including legal warranty of quality, on components, parts and accessories subject to normal wear and tear, or damaged by corrosion. Manac shall not be responsible for damage to or loss of goods, loss of time or profits, or for any other charges or fees which may be incurred by reason of defects in the Equipment. Manac's sole obligation under this warranty shall be to repair, or, at its discretion, replace free of charge any defective components, parts and accessories covered by this warranty. WITH THE EXCEPTION OF ADDITIONAL DEGRESSIVE WARRANTY WHICH MAY APPLY TO A SPECIFIC PRODUCT, THE PRESENT LIMITED WARRANTY REPLACES ANY OTHER WARRANTY, EXPRESS OR IMPLIED AND MANAC SPECIFICALLY DISCLAIMS ANY OTHER WARRANTY, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Any defect must be reported to Manac in accordance with the policies and warranty procedures of Manac within five (5) days following the day it first appears, failing which the warranty will be void. Unless Manac otherwise provides its prior written consent, all repairs must be performed at a Manac parts and service center.

Manac's sole obligation under this warranty shall be to repair, or, at its discretion, replace free of charge any defective parts covered by this warranty. WITH THE EXCEPTION OF THE ONE YEAR LIMITED WARRANTY WHICH APPLIES TO ALL MANAC PRODUCTS, THE PRESENT ADDITIONAL DEGRESSIVE WARRANTY REPLACES ANY OTHER WARRANTY, EXPRESS OR IMPLIED AND MANAC SPECIFICALLY DISCLAIMS ANY OTHER WARRANTY, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
